# **Highlights**

Professor **Joy Xiang** published Climate Change, Sustainable Development and Clean Tech: A Pathway for Developing Countries (Edward Elgar Publishing 2022).

Associate Professor **Stephen Minas** represented the United Nations Climate Change Committee, of which he is a member and Chair of the Technology Subcommittee, at the November 2022 intergovernmental COP27 Climate Change Conference in Cairo. Professor Minas also has created an international podcast, *The STL Law & Sustainability Colloquium*, that features prominent guests discussing pressing issues pertaining to sustainability, climate change, energy, and the environment.

Professor **Asif H Qureshi** organized a hybrid workshop of "Law Reforms around the World" on November 19 and 20, 2022. The two-day workshop brought together leading experts and scholars in the field of law reform from China, the United States, the United Kingdom, continental Europe, Latin America, Africa, and other countries and regions, to conduct in-depth discussions on topics related to contemporary national law reforms, with the purpose of promoting law reform and enhancing cooperation between law reform institutions.

**STL first class** (2008-2012) started Gray Student Development Fund at STL in memory of their Contract professor Whitmore Gray, who passed away in 2018. The program is also to remember and appreciate all those who, like Professor Whitmore Gray, have contributed to the development of Peking University School of Transnational Law ("STL") and Chinese legal education, and to boost the further development of STL.
