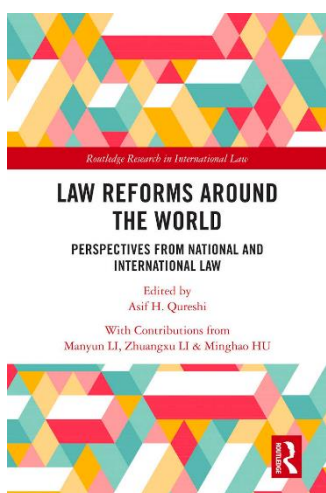
Highlights



STL celebrated a remarkable milestone on October 22, 2023, as it marked its 15th anniversary. The event drew a distinguished gathering of luminaries, including Liu Xiaochun, President of Shenzhen Court of International Arbitration; Cao Hailei, Deputy Director of Justice Bureau of Shenzhen; Zhang Jin, Vice President of Peking University and Chancellor of PKU Shenzhen, who is also an Academician of the Chinese Academy of Sciences; Hai Wen, Founding Dean of PHBS and Vice Chairman of the Peking University Council; Jeffrey Lehman, Founding Dean of STL and presently Vice Chancellor of New York University Shanghai; Liu Zhewei, Associate Dean of Peking University Law School; Stephen Yandle, Vice Dean Emeritus of STL; Mark Feldman, Interim Dean of STL; Philip McConnaughay, who served as STL Dean from 2013 to 2023, participated via video presentation. The celebration brought together students, alumni, and friends of STL from all over the world and across China at the STL building. The event served as an opportune moment for reflection on STL's journey and an exploration of its promising future.



On December 15, 2023, the inaugural "State of STL" event took place in the STL lobby. Faculty, students and alumni, along with invited guests from law firms, enterprises, courts, procuratorates, and arbitration institutions, gathered to reflect on the remarkable accomplishments of STL's faculty, students, alumni, and staff over the past year. The occasion also provided an opportunity to anticipate STL's major strategic directions and important initiatives for the future.



The book “Law Reforms Around the World: Perspectives from National and International Law” edited by STL Professor Asif H. Qureshi has been published by the leading global publisher Routledge Press. The book is based on a conference organized at STL in 2022 involving 36 academics, professionals and international civil servants drawing from legal experiences in countries from Asia, Australia, Europe, Africa, Latin America and the USA. An important chapter in the book titled “Mapping of World Law Reform Institutions” was jointly written by Manyun LI, Zhuangxu LI and Minghao HU from the class of 2021 of STL. STL professors Huang Hui and Danny Friedmann and STL alum Ma Ji also contributed to the book.

PKU Shenzhen Research Center for Regional and National Law, based at STL, was established with the support of Shenzhen government. Under the leadership of Professor Huang Hui, work of the Center will include a wide range of research areas: (i) AI policy and risk regulation, (ii) digital governance and data protection, (iii) risk prevention of cross-border investment by Chinese enterprises, (iv) international investment arbitration, (v) ESG standards in China and (vi) legal systems of Islamic countries. The Center will provide academic support, with an international perspective, for China's development of law and policy and international engagement.



Professor Mark Feldman was appointed as Interim Dean of Peking University School of Transnational Law ("STL"). He joined STL as Assistant Professor of Law in 2011 and has taught more than 1000, and served as thesis advisor for more than 100 STL students. He previously served as a member of the T20 Saudi Arabia Task Force on Trade, Investment and Growth, as a member of the E15 Initiative Task Force on Investment Policy (World Economic Forum/ICTSD), and as Chief of NAFTA/CAFTA-DR Arbitration in the Office of the Legal Adviser at the U.S. Department of State. In the private sector, he practiced law for several years at Covington & Burling.



The 8th Public Interest Law Foundation (PILF) Auction was held on the evening of May 20th, 2023 in the STL lobby. The event featured 80 auction items donated by professors, alumni, and students from STL and Peking University Shenzhen Graduate School, as well as various student organizations and clubs. The total transaction amount exceeded 80,000 yuan, including nearly 50,000 yuan in cash donations and sponsorships.

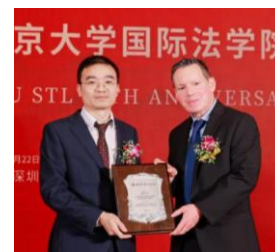


On April 1, 2023, STL celebrated the 10th anniversary of its first and second graduating classes. Alumni from the class of 2012 and class of 2013 returned to the Peking University Shenzhen campus to reconnect with former classmates, professors and reminisce about old times. The event was organized by the STL Alumni Office and co-organized by the "Home of Nanyan Alumni" student association of the Peking University Shenzhen Graduate School.



From March 25-26, 2023, STL held a Workshop on Algorithmic Recommendation and Law, co-initiated by Professor Gilad Abiri from STL and Professor Zheng Ge from Koguan School of Law at Shanghai Jiao Tong University. The workshop invited experts and scholars from top universities and institutions such as Peking University, Fudan University, China University of Political Science and Law, Shanghai Jiao Tong University, Beihang University, University of International Business and Economics, and Tencent Research Institute. The conference mainly discussed the opportunities and challenges brought by the rapid development of recommendation algorithm technology, analyzed, and proposed suggestions for accompanying legal regulatory issues.

STL alumnus Zhou Qing from graduating class of 2016 launched the "Shouzheng Scholarship" at STL, which stands as the first scholarship program funded by donations from STL's individual alumnus.
